This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

- 1. The Contract End Date is extended to August 14, 2020.
- 2. The Maximum Contract Amount is increased by \$31,906 to a new Maximum Contract Amount of \$63,812.
- **3.** Special Terms and Conditions, Section 5, Consideration is replaced with the following language:

Total consideration payable to Contractor for satisfactory performance of the work under this Contract is up to a maximum of \$63,812, including any and all expenses, and shall be based on the following:

- a. \$1,330 for submission of the required reporting documents for the period of August 15, 2018 August 31, 2018.
- b. \$2,659 per month for submission of required reporting documents for the period of September 2018 through July 2020 for up to a maximum of \$58,498.
- c. \$1,327 for submission of the required reporting documents for the period of August 1, 2019-August 14, 2019.
- d. \$1,330 for submission of the required reporting documents for the period of August 15, 2019 August 31, 2019.
- e. \$1,327 for submission of the required reporting documents for the period of August 1, 2020 August 14, 2020.

All other terms and conditions of this Contract remain in full force and effect.
