This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

1. The contract end date is extended to September 30, 2023.
2. The Maximum Contract Amount is increased by **\$169,384.20** for the FY23 (10/1/2022 – 9/30/2023) program year, to a new Maximum Contract Amount of **\$306,934.30** with the following breakdown:

3. Special Terms and Conditions, Section 5, Consideration is replaced with the following language:

5. Consideration

- a. The total consideration payable to Contractor for satisfactory performance of the work under this Contract, including any and all expenses, is based on the following breakdown:

(1) In FFY22, from 10/1/2021 to 9/30/2022, a maximum of \$31,906.00:

- i. \$2,658 per month services outlined in the Statement of Work and submission of a monthly Participant Services Report for the period of October, 2021 through August, 2022 (maximum of \$29,238),
- ii. \$2,668 for services outlined in the Statement of Work and submission of a monthly Participant Services Report for the period of September, 2022.

(2) In FFY22, from 4/1/2022 to 9/30/2022, a maximum of \$68,738.10:

- i. \$11,456.35 per month for services outlined in the Statement of Work and submission of the monthly Participant Services Report for the period of April, 2022 through September 30, 2022.

(3) In FFY23, from 10/1/2022 to 9/30/2023, a maximum of \$169,384.20:

- i. \$2,659 per month for services by the International Medical Clinic outlined in the Statement of Work and submission of a monthly Participant Services Report for the period of October, 2022 through September, 2023.
- ii. \$11,456.35 per month for services by the Pediatric clinic outlined in the Statement of Work and submission of a monthly Participant Services

Report for the period of October, 2022 through September, 2023.

- iii. The Contractor and DSHS will meeting during FY23 program period to further review the program goals and objectives to evaluate program structure and staffing needs. If necessary, program amendments agreed upon between all entities involved with the program will be considered.

All other terms and conditions of this Contract remain in full force and effect.
