This Contract between the State of Washington Department of Social and Health Services (DSHS) and the Contractor is hereby amended as follows:

1. The Maximum Contract Amount set forth by page one (1) of the Contract is increased by \$110,000. The new total Maximum Contract amount shall be \$227,940 for the remainder of the duration of the Contract term. The new Maximum Contract Amount, as agreed to by DSHS and the Contractor, shall be applied retroactively to January 1, 2022.
2. Exhibit B, Statement of Work, Section 6. Consideration, is replaced with the following language for the specific Payment Point listed below:

The Contractor shall receive payment up to **\$168,970.00** during the FY22 contract period based on the following:

Payment Point 1: **\$2,000** per month for clinical operating costs when there are zero new refugee screenings completed, however, clinical operations and administrative services continue (as approved by DSHS).

\$4,000 per month for clinical operating costs when there is at least 1 new refugee screening completed (does not permit follow-up as a qualified criteria) from October 1, 2021 – March 31, 2022.

\$6,000 per month for clinical operating costs when there is at least 1 new refugee screening completed (does not permit follow-up as a qualified criteria) from April 1, 2022 – September 30, 2022.

All other terms and conditions of this Contract remain in full force and effect.
